Withdrawal Deadline - Thursday, December 21, 2023, at 12:00 NOON, prevailing time.

IDENTIFICATION REQUIRED

Federal or state government issued PHOTO ID is required to vote, unless an exception applies. Any one of the following can be used as identification even if expired:

- Tennessee driver's License with your photo,
- United States Passport Photo ID,
- Tennessee Department of Safety and Homeland Security Photo ID,

- Photo ID issued by the Federal or Tennessee State Government, such as an Employee ID from the U.S. Department of Energy with your photo,
- United States Military Photo ID, including a Veteran Identification Card with photo,
- Tennessee State Issued Handgun Carry Permit Card with your photo.

Notice is hereby given that elderly voters and voters with disabilities assigned to vote in precincts where the polling place is inaccessible may vote early at the Election Commission Office during the early voting dates or by absentee ballot by mail or may vote at the Election Commission Office on Election Day. Any elderly voter or voter with disability desiring to vote at the Election Commission office on Tuesday, March 5, 2024, must complete an affidavit at the Election Commission office by Saturday, February 24, 2024, of his/her intention to vote at the commission office on Election Day.
